## Tuesday, May 26, 2020 from 12-1:15pm EDT Universal Protocol Form, CUSP, and The Guide (Hosted by the Animal Care & Use Subcommittee)

In conjunction with the FDP, the IACUC Administrators' Association (IAA), OLAW and the USDA support the project of developing a standardized IACUC animal protocol template as an initiative to reduce burden on investigators as stated in the 21st Century Cures Act. During this session, we will review the progress that has been made since the last FDP meeting, including critical review of questions on the current template, and the working group's next steps. This session will also include an update on the development of the CUSP Sharing Site, an online resource where institutions can share standard procedures used in animal care protocols. The CUSP project is also a burden reducing initiative of the 21st Century Cures Act.

In addition, NIH/OLAW and the National Academies of Science will be hosting a brief listening session to gather input from the community on updating The Guide for the Care & Use of Laboratory Animals.
