

# Research Compliance Committee (RCC)

 The Research Compliance Committee reviews existing and new administrative requirements imposed by federal regulations and program officers related to research compliance with an emphasis on harmonization of requirements across federal agencies, reduction of redundancies, and identification of good practices. This includes but is not limited to human subjects protections, animal care and use, conflict of interest, export controls, and data stewardship.

# RCC Animal Care and Use – IACUC MOU Working Group

- Co-Chairs: Amanda Humphrey (Northeastern) and Keri Godin (Brown)
- Collaboration with Subawards to create a sample MOU and corresponding guidance to codify each institution's responsibilities related to the care and use of animals when collaborating on vertebrate animal research.
- Progress over the previous year:
  - Via two subgroups, generated rough drafts of a sample MOU and associated guidance. Also met as a larger group to ensure alignment between the two draft work products.
- Goals for upcoming year:
  - Complete final working draft of MOU document and pilot at volunteer institutions
  - Publish guidance for feedback from FDP member community



### RCC Animal Care and Use – CUSP

- Alpha Testing in Progress!
  - Initial testing of system to identify major bugs, usability issues, and feature gaps.
  - Largely performed by tech team and 2-3 institutions
  - Dev Team: David Wright (FDP-designated resource)
  - Testers: Scott Bury, Elaine Kim, Ellen Ladenheim, Eva McGhee
- Fall 2020 AALAS National Meeting Session (panel and demo video) - On the CUSP: A New Option for Addressing Administrative Burden
- Drafting Help Page content for new users (e.g., data dictionary, user definitions)



- Beta Testing anticipated to begin in Q1 of 2021
  - Second phase of testing to identify bugs and other technical issues
  - Addition of download and SSO features
  - Includes 6-8 institutions
  - Will collect additional feedback to help with implementation (e.g., FAQs).
  - Business process (and supporting materials) ready for beta testing.
  - Training of testers completed!

### Contracts: Subcommittee Goals

- Co-Chairs:

- Goals:
  - To identify common practices in contracts processing that can be expedited by uniform procedures within FDP;
  - To design, monitor, and evaluate new procedures and concepts that respond to the legal requirements of the contracts process, but do so more efficiently;
  - To study the similarities and differences between the grant and contract process to see if gains in costs and efficiency can be generated by adapting some of the FDP grant procedures for use with contracts; and
  - To provide a forum for discussion of and possible resolutions for contracting issues as they arise for member institutions and agencies.

# Contracts: Progress and Next Steps

- Troublesome Clauses Database 2.0
  - Initial step is to develop and complete a survey of working group members to help COGR respond to an information request from DoD.
    - Will use this initial survey to help refine the data elements that should be included in the reinvented Troublesome Clauses Database.
  - Will reinvent the database to track information relevant to current issues in Contracts with an eye to selecting a platform that will make entering and accessing information user friendly.
  - Develop user guide materials for the database as well as guidance materials to help member organizations identify and navigate the clauses currently causing the most trouble!
