USDA Enterprise Solution for Grants Management ezFedGrants

- Foreign Agricultural Service portal is live, as of this week
- NIFA will go live for FY 2017 capacity programs in late October/November (APHIS also is in this timeframe)



Capacity Programs

- Capacity Research Programs
 - Animal Health and Disease Research, Evans-Allen, Hatch, Hatch Multi-State, McIntire-Stennis Cooperative Forestry Research
- Capacity Extension Programs
 - Renewable Resources Extension, Expanded Food and Nutrition Education, Cooperative Extension at 1862s, Extension at 1990s, Smith-Lever Special Needs, and District of Columbia Public Postsecondary



What is NOT Changing

- Applicants will apply through Grants.gov just as the currently do – but read the RFA for slight modifications
- Grantees will utilize ASAP to draw funds just as they currently do
- Competitive awards will not be managed in ezFedGrants until a later date

- Level 2 e-Authentication

 - Industrial Hemp
 - Section 7606 of the Agricultural Act of 2014 ("Farm Bill")
 - Federal Register notice (Aug12, 2016; 81 FR 53395)
 - NIFA <u>https://nifa.usda.gov/industrial-hemp</u>
- Jan 2017 version anticipated
 - Implementation of Multi-agency Overlay Effort
 - Federal Register notice (Oct 14, 2015; 80 FR 61849) (<u>https://federalregister.gov/a/2015-26090</u>)
- Drafting Capacity Award Terms
- Updating 1890 Facilities Program Terms

- Award amendment Eliminates RFA and application submission to Grants.gov
- Subsequent increments of funding accomplished through an award amendment
- NIFA Program Staff will email the PD with guidance
