Focusing on administrative data throughout the life-cycle:

- Track, analyze, and streamline the **impact of data driven initiatives** on agencies, researchers and institutions
- Facilitate the adoption of **standards** and their implementation to ensure transparency goals are met while maximizing positive impact and minimizing burden on all partners in the process
- Coordinate and collaborate with other FDP committees as needed (e.g., ERA, Expanded Clearinghouse) to address data based components of mutual interest.
- Partner with the government (in the FDP tradition)
- Viewing data as a strategic asset and cornerstone for reducing workload







OpenGov: Financial Reporting

University (P1)

- advance expenditures and categories
- · budget categories and amounts
- expenditures by project and by category and amounts
- available balance to expenditures and categories
- payments received
- accounts receivable
- cash deficits
- encumbrances/commitments

Agencies (P1)

- Obligated funds
- Award amounts
- Advance payments
- Expenditures and deviations
- Income
- Payments

Reporting & Data Elements (P2)

- Inventory: What financial reports are required/requested (build on prior FDP work)
- Key Elements: What elements are in each report

Analysis (P3)

- Analysis
- Are there common elements
- · Are there duplicate elements
- · When/how often are elements generated
- · When/how often are elements communicated

OpenGov: LOC Drawdowns

Specific Process with Pain Points

- Letter of Credit (LOC) drawdowns are one of our simpler specific isolated processes
- This is an area that is 'less trodden' for federal and institutional attention
- Aligned with PMA CAP Goal 8
- Could be low hanging fruit to begin a data dictionary or more comprehensive post award financial conversation

Quantify Burden

• For LOC Drawdowns we can quantify 'burden' by measuring the time it takes to prepare for, complete, and reconcile drawdowns for each system, how many systems we interact with, and how may FTEs are dedicated to the issue for a given month in a given institution

Overarching Financial Data Dictionary

• Requires limited set of defined terms to contribute to data definitions

Survey

- An easy way to understand how the quantity of burden varies by institution size and type
- Scalable participation with relatively quick analysis and results

Analysis and report out

• Sharing the quantified results of 'burden' in a specific administrative process could stimulate federal resources to help streamline the process across grantors.
