

## Finance Committee Report

The Finance Committee devoted considerable efforts to working with the Membership Committee on recommendations for tiers of membership and the associated dues amounts for FDP's Phase VII Solicitation for Members. The Executive Committee approved the recommendations in December. There are a few notes of explanation:

- Tiers are based on NSF HERD Survey data for 2018. Institutions that do not submit HERD data can self-report R&D expenditure data directly to FDP.
- The plan keeps the initial increase in dues below a doubling level for all tiers.
- It preserves the ability of our smallest institutions, those with a HERD survey level of less than \$25M, to continue as members without paying dues.
- It allows FDP to meet our goal of doubling the revenue from dues, currently about \$250,000, but the mechanism is a two-step process.
  - The initial increase takes us to \$410,500 in the first 3 years of Phase VII.
  - Beginning in Year 4, we would increase dues for Tiers 1 - 3 by \$500. That additional increase in the out-years takes us to \$484,500 by year 4 of Phase VII.

### **Administrative Charge**

- Develop and maintain an overall communication and outreach plan for FDP.
- Set style guidelines for all FDP committees for all FDP publications in either electronic or print form.
- Provides oversight and direction for the FDP web site.
- Edit and approve publications that will have broad viewership to ensure the style, tone and grammar meets Communication Committee guidelines, in coordination with all other FDP Committees.
- Compile and disseminate high-level meeting summaries.
- Develop outreach materials, including brochures, PowerPoint templates, etc. to communicate FDP's current initiatives and accomplishments.

### **Progress in 2019 and Prep for 2020**

The Communications Committee went through many structural changes and positive steps to support the FDP in all outreach activities. The Committee was able to engage 47 new volunteers. Six working groups were created, each with its own lead(s), to drive the Committee's administrative charge and prepare for the next phase, Phase VII. Effective 11/5/2019, Stephanie Scott became the Co-Chair of the Communications Committee. The following are the accomplishments and plans for each of the newly formed workgroups:

**Marketing, Brochures and Outreach** (Leads: Barb Gardner, Tufts, and Sarah White, University of Tennessee Health Science Center)

- Currently finalizing a new brochure to accompany the FDP Phase VII solicitation and application package for new FDP members. Will conduct outreach to professional organizations for new members for Phase VII.

**Website** (Leads: Rasha Abed, Governors State University, and Jamie Sprague, Cornell University)

- Workgroup recently trained on MURA, FDP's website content management system.
- Workgroup will provide guidance on style and webpage structure for consistency.

**Session Summaries** (Leads: Benjamin Mull, University of Houston, and Jeff Petsis, University of Pittsburgh)

- Developed a new process to be implemented for the first time during the January 2020 meeting. Plan is to have the high-level session summaries for all meeting sessions to distribute to the community.

**Articles for Publications** (Leads: Michael Kusiak, University of California, and Jeff Petsis, University of Pittsburgh)

- Workgroup met to discuss future articles for NCURA Magazine article series, as well as other potential avenues.
- Seven articles published in 2019 in NCURA Magazine related to FDP activities and accomplishments.

**Policies, Style Guidance and Social Media** (Lead: Csilla Csaplar, Stanford University)

- Currently developing a broad communications policy statement for FDP.
- In early 2020, this working group will be drafting/updating guidance around use of name/logo, social media, and grammar/style, and is currently collecting and reviewing sample language and any existing FDP documents related to these.

**Infrastructure Liaisons for Project Management Tools** (Leads: Mora Harris, Johns Hopkins University, and Jim Taylor, Penn State)

- Workgroup leads met with the Infrastructure Committee representatives for perspective on current state of activities and needs.
- Will assess the current project management tools currently in use with FDP, and will organize quick guides, outreach and support mechanisms.
