Goal: Develop an online venue where participating institutions can share standard procedures used in animal care protocols.

	Alpha (in progress!)	<ul> <li>System construction</li> <li>Initial testing of system</li> <li>Identify major bugs, usability issues or feature gaps</li> <li>Tech team + 2-3 institutions</li> </ul>
	Beta (Q1 2021)	<ul> <li>Second phase of testing</li> <li>Addition of download and SSO features</li> <li>Identify bugs and other technical issues</li> <li>6-8 institutions</li> </ul>
	Pilot (Q2 2021)	<ul> <li>Last phase before release</li> <li>Simulates how system will be used in real life</li> <li>Evaluate qualitative aspects (e.g., how user friendly is the system)</li> <li>15-20 institutions</li> </ul>
	Go Live!	<ul> <li>Initial release limited to FDP community (~200 institutions).</li> <li>Site will be opened to larger research community in 2021.</li> </ul>
