- In partnership with eRA, we have supported the DATA Act and Section 5 roll out needs and information sharing
- Remainder of DATA Act timeline goes to May 2017 for the Section 5 work, the implementation of the DATA Broker, and the roll out of the new USA Spending

Expanded Clearinghouse

- Development of 1-stop shopping for institutions collecting entity data – elimination of all those forms!
- Current pilot project (Cohort 1 & 2):
 - 2/1/2016 through 6/30/2017
 - 79 FDP members, 127 individual entity profiles
 - Repository of excel entity profiles
- Pilot institutions are required to track usage to report on the effectiveness of the pilot
 - Final reporting period through 6/30/2017

Expanded Clearinghouse

- Web-based system tentative mid-February
 - Cohort 1 & 2 will create profiles and enter entity data at go-live
 - New Cohort 3 to enter data thereafter
 - All profiles uploaded and ready for use Spring 2017
