Working Group Process

- Gathered list of suggested changes from membership
- Discussed suggested changes:
 - Whether to incorporate them
 - How to incorporate them
- Revised documents, then sent out draft documents for review
- Worked toward agreement on UG-related revisions to subaward templates
 - ➤ Focused on Uniform Guidance-related revisions
 - ➤ Also collected list of non-Uniform Guidance-related revisions
- Finalized draft documents to be reviewed by FDP Subawards subcommittee

Process

- Draft templates sent to FDP subawards listserv in December
- Comments were posted to listserv directly or sent to subawards cochair
- Co-chair collated comments
- Working group leads & co-chair discussed UG-related comments and how to handle them
- Incorporated several (not all) suggestions from listserv into updated templates
- Set aside non-UG-related comments for discussion at a later date
