- Approximately 10 USDA agencies using, designing, or exploring the use of the system

## NIFA Release #1

- FY 2017 Capacity Awards will be processed through the system
- Work scheduled to start September 2015 and be finished before October 2016
- Applicants will continue to apply through Grants.gov and be paid through ASAP



# **New Capacity Award Process**

- Financial and Admin Functions
  - Award Submission
  - Award Creation
  - Amendment
  - Closeout
  - Self service portal for applicants

#### WILL NOT INCLUDE Changes to

- Reporting:
  - Plan of Work
  - REEPort

- Grants.gov Integration (USDA-wide effort)
- Application Review Process/Peer Review system (USDA-wide effort)
- ASAP Integration
- Competitive programs will be phased in during FYs 2017 & 2018



#### Update – Farm Bill Implementation

- Centers of Excellence (Section 7128)
  - First FY15 awards with Center of Excellence designation are being made
  - FY16 RFAs will continue to provide priority funding across competitive research and extension programs
  - Stakeholder feedback webinars were held Aug. 27 and Sept. 3 to inform the rulemaking process
    - Written comments on the implementation strategy should be sent to <u>centers@nifa.usda.gov</u> by Sept. 30



### Update – Farm Bill Implementation

- Commodity Boards for AFRI (Section 7404)
  - Commodity boards were invited to propose topics for AFRIs RFA – 100% match required
    - RFA deadline for FY 2016 is Sept. 22
  - Once topics have been evaluated, commodity boards will be notified and selected topics will be incorporated into FY 2016 AFRI RFAs
    - PDs seeking co-funding under these topics will be required to submit letters of support from commodity boards



#### Update – Farm Bill Implementation

- New Matching Requirement of 100%
  - Guidance published on NIFA's website describing covered competitive programs, process for requesting a waiver
  - Majority of grantees excepted with no waiver needed
    - Non-Land-Grant Colleges of Agriculture can be certified, excepted – public with 4 year food and ag science degrees

# **Progress/Financial Report Letters**

- Letters sent about reports becoming due/overdue
- New language
  - Awardees must submit periodic technical and financial reports to NIFA to ensure proper stewardship of federal funds. Failure to submit this report may impact the availability of future grant funds or the approval of post-award actions.
