DFARS clause on Safeguarding Covered Defense Information...

- DFARS Clause 252.204-7012, entitled "Safeguarding Covered Defense Information and Cyber Incident Reporting".
- Clause should be in any DoD contract, except one solely for the acquisition of COTS items, going back as far as November 13, 2013.
- Current version of clause (dated October 2016) required implementation of NIST Special Publication (SP) 800-171 by December 31, 2017.



DFARS clause on Safeguarding Covered Defense Information...(cont.)

- Revision 1 of NIST SP 800-171 was issued in December 2016 but that revision is not referenced in the current DFARS clause.
- DPAP Memorandum*, dated December 15, 2017, indicates that contract administrative components (e.g., ONR, DCMA) should issue mass modifications to facilitate any requests from Contractors to update the NIST standard to Revision 1 in their DoD contracts.

DFARS clause on Safeguarding Covered Defense Information...(cont.)

- Contractors still desiring that their DoD
 contracts with this clause be updated to
 Revision 1 of NIST SP 800-171 should email their
 assigned ONR Administrative Contracting Office
 (ACO), if they are a university or nonprofit
 organization under ONR's cognizance, or the
 DCMA ACO if that organization has cognizance.
- If the contractor is making such request to ONR, it should provide a list of DoD contract numbers for which it is requesting this modification.



New Initiatives

- New payment system planned for DoD Grants and Cooperative Agreements and potential pilots being discussed prior to full implementation.
- Potential request to change policy to allow grant payments with low risk recipients to be made without grants officer certification, i.e., similar to direct pay in DoD contract world.
- Contract quick close-outs.
- Overpayments/Refund Checks.

- ONR Acquisition Department's Paperless Initiative.
- All new indirect rate proposals will be electronically submitted. Options include email (small files) and AMRDEC Safe (large F&A proposals).
