PAYMENTS



New-

- New awards no longer include "scheduled" advances, except in unusual circumstances
- Recipient's payment requests can be:
 - ✓ "advance" or
 - ✓ "reimbursement"
- Select payment method, as needed (thru WAWF)
- Reimbursement should be the primary method used
- Advances must be justified and approved by the Grants Officer



FUNDING



What is the effect of no longer having scheduled advance payments? Must pay close attention to the "Life" of our RDT&E funds

Gov't has <u>2 Years</u> to Obligate Funds on an Award

Example:

Fiscal Year 2016 (10/1/15 – 9/30/16)

Gov't must obligate by 9/30/17

Gov't has <u>5 Years</u> to Disburse Funds

- "Life" ends 9/30/22
- All funds must be paid by Gov't by 9/30/22
- Undisbursed funds are returned to the US Treasury



FUNDING



CAUTION: With reimbursement payments

- ▶ If
 - Award is fully funded upon award (all funds obligated), and
 - Award is for 5 years
- ➤ Must invoice and be paid within 5 years
- Extensions to period of performance not possible
- Project timeline must be closely monitored
- Undisbursed funds must be returned to US Treasury





- DoD continues to implement 2 CFR part 200
- DoD Grant and Agreement Regulations (DoDGARs)
 - DoDGARs located at 32 CFR
 - Parts still in effect: Parts 21, 22, 26, 28, 34, 37
 - Parts replaced by 2 CFR 200:
 - Part 32 Administrative Requirements for Institutions of Higher Education, Hospitals, and Other Nonprofits
 - Part 33 Administrative Requirements for States
 - DoD's Interim Implementation Plan
 - See Federal Register Notice: 12/19/15





- Currently: DoD's Revised Interim Implementation Plan
- Published in 6 Federal Register Notices: 11/7/16
 - Supersedes "Interim Implementation Plan"
 - **X** Addresses:
 - » definitions, standard award format, administrative requirements, national policy requirements
 - **×** Comment period ends on 2/6/17
- Further implementation ongoing (DoDGARs Working Group)
 - » Addressing pre-award requirements, administrative requirements with for-profit organizations, Technology Investment Agreements
